Sub :- Continuation of Affiliation for RGNM programme for the A.Y.2015-16 with intake of 20 (twenty) seats.

Sir/ Madam,

The Maharashtra Nursing Council (MNC) examined the documents submitted by **School of Nursing, Parkar Hospital, Ratnagiri** for permission to **R.G.N.M** programme for the academic year **2015-16**. Maharashtra Nursing Council conducted inspection of the institution by a team of inspectors appointed by the Council in **July 2015**.

The **General Body Meeting held on 22/07/2015** evaluated the inspection report & your institution is permitted to R.G.N.M. programme with an intake capacity of **20 (twenty)** students for the academic year **2015-16**. Affiliation is granted by MNC on fulfillment of all criteria as mentioned in reference no. 02 and subject to the following conditions:

1. This affiliation is only for the A.Y. 2015-16.
2. The admitted students should be enrolled online from **1st August 2015 to 30th September, 2015**. Any extension in date of admission if granted by INC, the software limitations at MNC will not support it. The username and password should be preserved by a permanent responsible staff of your school.
3. The minimum educational requirement shall be **12th** passing out from recognized board. Preferably Science Subject.
4. Adequate articles, equipments in CHN & FON lab should be made available.
5. Teaching Staff – Principal & all appointed teachers should be eligible, qualified, experienced as per norms & registered with MNC before their appointment. 1:10 teacher: students ratio should be maintain. **Tutors should not leave the institutions during the academic year else their registration will be suspended as per Sec. 23 of MNC Act 1966.**
6. Do not admit underage & overage students.

7. Check council's website – www.maharashtranursing council.org frequently.
8. Maintain all the records and reports as per the norms of this programme.
9. Submit the INC validity for A.Y. 2015-16 to the council before 31st August 2015 as a prerequisite for online admission enrollment.
10. **Male Candidates admission should be restricted to 10%.**
11. There should be at least 10 candidates in the batch else the batch will not be permitted for the Council's examination.
12. By 30th October every institution should pay yearly Bed Affiliation fee and inspection fee of Rs. 15,000/- to be paid once in every three academic years.


This affiliation is granted on the basis of possessing EC/SC and compliance of bed affiliation fees of MNC.
